Constanta City



- Inhabitants 316.263 locuitori / 491.692 (FUA)
- > Surface 124.89 km² / 1,013.5 km² (FUA)
- Port City
 - Maritime and Fluvial Port
 - Largest and deepest port on the Black Sea
 - Connected to all modes of transport
 - 66,60 mil tone of commodities processed in 2019


> Tourism City

- Oldest City in Romania (ancient Tomis citadel)
- Mamaia resort (around 30.000 lodging units)
- Over 1 mil. tourists visit Metropolitan Area resorts every year

University center

City administration

- Local Council decision body
- Mayor executive body
- Functioning principles: Local autonomy and self-governance

Port administration

- National Company "Maritime Ports Administration" S.A. Constanta – Port authority
- State owned company subordinated to the Ministry of Transport, Infrastructure and Communication

Integration of SUMP with PMP

- To improve the cooperation process between the City and Port authorities
- To obtain a common and integrated vision regarding the sustainable development of the City, including the Port area

Establishing a Mobility Forum

To establish a Mobility Forum composed of key representatives/professionals of the main mobility stakeholders from different decision levels with the scope of promoting sustainable integrated urban mobility policies






Activities undertaken for establishing Constanta Sustainable Urban Mobility Forum



- Identifying the relevant stakeholders in the field of mobility and urban planning
 - Analyses of the national and European legal and institutional framework in the field of mobility and urban planning
 - Analyses of best practice examples regarding stakeholders engagement
- Establishing the modus operandi of the Mobility **Forum**
 - inter-institutional organization, without personality, established with the aim of offering an open platform for public debates in the field of people and freight movement, as well as urban planning
 - The MF works in **plenary open sessions** and in working groups (WG 1 - Public Transport; WG 2 -Parking; WG 3 - Central Area Accessibility; WG 4 -Freight Transport; WG 5 - Neighborhood level mobility)

Mobility Forum activities



Mobility Forum meetings

- → 40 meetings over 500 participants (public) bodies /universities / public and private companies / NGOs / general public)
- different formats (workshops/ thematic discussion / presentations with debates/ experts meetings)



- Introduction of PT inside the Port area
- City parking policy
- Reallocation of street space in the City
- Vehicle access restriction regulation in the historical city area
- Establishing the Public Transport Authority at the metropolitan level
- PORTIS awareness raising campaigns















Lessons learned



- 1. Cooperation of stakeholders at an executive level is necessary for the swift design and implementation of mobility measure but not sufficient
- 2. Involvement of the political representatives from the early stages of design is fundamental for the successful adoption of sustainable mobility measures
- 3. It is not enough to organize and participate in meetings regarding sustainable mobility actions if further steps are not considered and followed appropriately
- 4. Politics context matters
